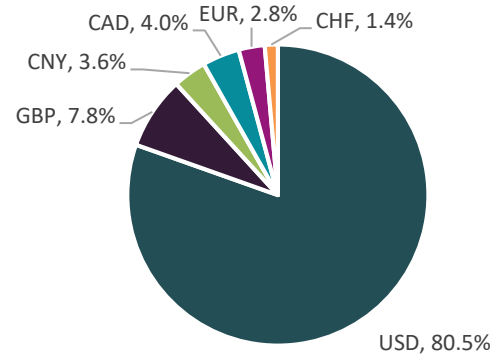
#### INVESTOR PROFILE

#### COMMENTARY

The portfolio was up 9.8% over the month of November compared to its benchmark MSCI World Index which was up 11.4% over the same period. At a stock level, the portfolio benefitted from positions in Berkshire Hathaway, Alphabet, Chevron, AbbVie, BlackRock and Associated British Foods. The main detractors over the month comprised of Alibaba, Reckitt Benckiser, Hormel Foods, Skyworks Solutions, Public Storage and Activision Blizzard.
