
## **INVESTOR PROFILE**

## STRATEGY AND OBJECTIVES



#### **COMMENTARY**

The portfolio was down 3.7% over the month of August compared to its benchmark MSCI World Index which was down 3.5% over the same period. At a stock level, the portfolio benefitted from positions in Novo Nordisk, IPG Photonics, Starbucks, Ashtead Group, CH Robinson and Public Storage. The month saw minor corrections particularly from the big tech stocks and unsurprisingly, the main detractors were Amazon, Facebook, Apple, Alphabet, LKQ Corp and Chevron.
